Marriage Matters

I was driving by a church one day just as a wedding was ending. The bride and groom had emerged and the crowd was throwing rice (or birdseed) at the happy pair. I momentarily found myself a little surprised that people were still getting married and then I laughed at myself. "You have been watching far too much television," I said.

Then I saw an article in World Magazine titled, "Marriage Matters." Well, of course it does, I thought, but then I remembered not everyone thinks it does any more. The article was an interview with David Blankenhorn who, in his newest book, argues against samesex marriage—and for leaving homosexuality out of the debate. The book was titled The Future of Marriage (Encounter, 2007). Marvin Olasky was doing the interview, and he said, "You write that 'across cultures, marriage is above all a procreative institution. It is nothing less than the culturally constructed linchpin of all human family and kinship systems.' What is some of the anthropological evidence for that?"

The author had spent an entire year studying what all the great anthropologists had concluded

about marriage. He wanted to learn if there were any common features of marriage across human societies and cultures.

What is always a core purpose of marriage, in every known human society? Here is the answer: "Everywhere, marriage exists in large part to ensure that the woman and the man, whose sexual union makes the child, stay together in a cooperative union to raise the child... This finding is widely shared—it is not really controversial—among the leading scholars of marriage in the modern period."

Now this is interesting, because he lays down a marker for why the state has an interest in protecting the institution of marriage. If you are old enough, you remember the days before nofault divorce—a time when some states had Draconian laws regarding divorce, a time when the wealthy flew to Reno, stayed long enough to establish residency, and then got a divorce in that state. Now what business did the state have interfering with the right to divorce, to swap one woman for another?

David Blankenhorn suggests it was for the children. That's a slam dunk really. It might have been rational to change divorce laws to allow no-fault divorce after the kids leave home, but the state has a vested interest in requiring parents to take care of any kids they bring into the world. We don't allow new mothers to toss a newborn into the dumpster. We don't allow mothers who are frustrated with a "terrible two" to drown him in the bathtub. We don't allow people to lock their little kids in the house and take off to Mexico for a week,

leaving the kids with no one to care for them. We require parents to provide food, shelter, clothing, and a reasonably good environment for kids

A long time ago, the prophet Malachi got a message from on high about divorce. It was short and simple: "Thate divorce,' says the LORD God of Israel" (Malachi 2:16 NIV). Strong words, those. What are we to make of them? As always, context is vital. If you study the entire chapter, you come to the answer in verse 15. God made male and female one: "And why one? Because he was seeking godly offspring."

Usually, when the versions use the word "godly," they are rendering a Hebrew word that means roughly—pious or religious. Not here. In this place, the word is elohim, the word most often used to describe God himself. The lexicon tells us that elohim, in the ordinary sense, means "gods." So how should we take this? Perhaps, "that he might seek godlike offspring." I checked five versions and found no acknowledgment of this distinction. So, why does God hate divorce? In simple, modern terms, "It's the children, stupid."

Paul had to deal with a very real, and somewhat new situation in his letter to the Corinthians. They weren't living in a Jewish society, and there were quite naturally, marriages between believers and unbelievers. What was the controlling issue in this time and place? After some discussion of the issue, Paul comes to the core of it in 1 Corinthians 7:13-14:

"And if a woman has a husband who is not a believer and he is willing to live with her, she must not divorce him. For the unbelieving husband has been sanctified through his wife, and the unbelieving wife has been sanctified through her believing husband.

Otherwise your children would be unclean, but as it is, they are holy."

Thus Paul also lays down a marker relative to divorce. It is all about the children. I have a lot more to say about this, and I did so in a recent audio presentation titled, "Why Marriage Matters." Proclaim Liberty throughout the Land!

You'll probably recognize the title of this essay as a quotation from the Liberty Bell. Proclaim liberty throughout the land! That quotes part of a verse from the Book of Leviticus and can be found in chapter 25. "Proclaim liberty throughout all the land unto all the inhabitants thereof" is in part from verse 10 of that chapter, and it refers to the Jubilee year, which came around every 50 years.

The Jubilee is based on the agrarian notion that wealth is in the land. Families had inheritance in the land, but often because of poor management or bad fortune, the family would lose the land and hence its means of financial freedom. In an agrarian society, to lose the land meant to lose your freedom, for you would then have to work for someone else in order to gain your daily sustenance.

But during the Jubilee, on the Day of Atonement (commonly known as Yom Kippur), the priests would sound the trumpet and all the inhabitants of the land were allowed to go back to the family homestead to reclaim their inheritance. Once every 50 years, liberty was proclaimed in the land and everyone would have a fresh start, regardless of the mistakes that they or their forefathers might have made.

In a sense, the land in Israel could not be sold but could only be leased until the year of Jubilee.

Early in his ministry, Jesus went back to his hometown of Nazareth. He entered the synagogue, opened the Scriptures to Isaiah 61 and read, "The Spirit of the Lord is upon me, because he hath anointed me to preach the gospel to the poor; he hath sent me to heal the brokenhearted, to preach deliverance to the captives, and recovering of sight to the blind, to set at liberty them that are bruised, to preach the acceptable year of the Lord."

2008 CEM Feast of Tabernacles

Although it has been the goal of Christian Educational Ministries to find a semi-permanent home for the observance of the Feast of Tabernacles, weather and facility conflicts have made that impossible the past several years. Since 2002, we have observed the Feast in a different location each year. A conflict at the Emerald Coast Conference Center in 2008 forces us to move once again.

Not all problems end in disappointment, though, because we have found a wonderful place to observe the Feast next year. We are pleased to announce that CEM will be observing the 2008 Feast of Tabernacles at the beautiful Boardwalk Beach Resort in Panama City Beach, Florida. The Boardwalk Beach Resort is three separate properties on the shores of the Gulf of Mexico. The resort consists of a hotel, condominiums, and a convention facility. The properties boast a 1,100 foot beach, the largest private beach on the coast. They are part of 13 different housing units in Panama City Beach, managed by Royal American Hospitality and will allow us to provide discounted housing for almost every budget.

Located on the west end, the Boardwalk Hotel affords you the luxury of having all the amenities and views of the resort, including the Activity Center, B.W. McCaw's Kid's Club, arcade, fitness center, Under the Boardwalk Bar & Grille. The beach is just a few steps away along the boardwalk. Adjoining the hotel is the Boardwalk Beach Condominium, a 22-story facility on the beach.

The Boardwalk Convention Center has over 20,000 square feet of meeting space, which provides plenty of space for the traditional CEM Feast. The ballroom holds about 1,000 people, and can be opened up to provide more seating, which will be ample room for worship services. There are three large rooms perfect for the many educational seminars held during the Feast. The CEM Youth Educational Adventures (YEA) classes
